IIIT Allahabad (IIITA), Prayagraj is an Institute of national importance declared under the act of Parliament to provide Education and Research in ICT related domains of Engineering, Technology, Science & Management Studies. The positions given below are purely temporary and appointments will be offered on contractual basis, with a fixed consolidated remuneration for a period of **11 (ELEVEN) month**, at IIITA's Health Centre, Prayagraj.

General Instructions

- 1) The appointment is purely on contract basis for the period of ELEVEN months from the date of contract. The performance of the appointee shall be reviewed/ assessed by the Competent Authority of the Institute during the contract period.
- 2) The first three months of the contract shall be a performance assessment period. The Institute reserves the right to terminate the contract during this period without notice, if the appointee is found medically, professionally, or administratively unsuitable for the post.
- 3) The contract may be extended/ renewed based on requirement, if any, of the institute and the performance review of the candidate.

- 4) The candidate must be registered as a medical practitioner with the Medical Council of the State/UT in which they are practising, or with any State Medical Council, and must be willing to obtain registration with the U.P. Medical Council before joining, if not already registered.
- 5) A Candidate should ascertain, before applying, that he/she satisfies all the eligibility conditions as stipulated in the advertisement. Candidates, who do not satisfy with the eligibility conditions, will be liable to be disqualified at any stage of recruitment.

- 9) Candidates should send self-attested copies of certificates and mark-sheets from matriculation onwards in support of their qualifications. Original certificates must be produced at the time of Personal Discussion / Interview/ Presentation.
- 10) Certificate(s) in support of experience (if any) should be in proper format i.e it should be on the organization's letter head, bearing the date of issue, specific period of work, name, designation and signature of the Administrative Authority/ Owner of the Organization along with the seal of the organization.
- 11) SC/ST/OBC candidates are required to attach the caste certificate as per format prescribed by the Govt. of India.
- 12) Only shortlisted candidates will be called for Personal Interaction / Presentation / Interview before a Selection Committee. The shortlisted candidates shall be informed separately.
- 13) The date of determining the eligibility of all candidates in every respect shall be the normal closing date of Advertisement.
- 14) No correspondence will be entertained from candidates regarding postal delays, conduct and result of interview and reasons for not being called for Interview / Presentation.
- 15) No T.A. / D.A. will be paid for attending the Interview / Presentation.
